"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land on the Southern side of Buncombe Street in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as A. Hahaffey on plat of property of Eliza Powell reserded in Plat Book C, at Page 16, and having, according to said plat, the followize retes and bounds, to-wit:

BEGINNING at a stake on Southern side of Buncorbe Street 145 feet, more or less, in a Southeasterly direction from the intersection of Lloyd Street and Buncombe Street at corner of precenty formerly owned by Stephen king; thence along the Southern side of Euncombe Street in a Southeasterly direction 63.5 feet, more or less, to an iron pin at the corner of property now or formerly of Carlisle; thence with the line of that property S. 56-03 7. 208.5 feet to pin at corner of property now or formerly of Thomas H.
