All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot #8, on plat of Eastgate Subdivision, made by Piedmont Engineers & Architects recorded in the RMC Office for Greenville County in Plat Book 4X at Page 31.
