WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Two Thousand and No/100

(\$ 22,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of S.C. Highway No. 253, and being shown and designated as Lot No. 1 and a portion of Lot No. 2 on Plat of Fontana Forest, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book YY at Page 171, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the northerly side of S.C. Highway No. 253, said pin being situate at the southeasterly corner of Lot No. 1, and running thence with said Highway S. 66-00 W. 100 feet; thence continuing with said Highway S. 67-10 W. 66 feet to a point in the front line of Lot No. 2; thence on a new line through Lot No. 2, N. 16-55 W. 159 feet, more or less, to a point in the rear line of Lot No. 2, said point being N. 70-37 E. 34 feet from the joint rear corner of Lots Nos. 2 and 3; running thence N. 70-37 E. 66.5 feet to the joint rear corner of Lots Nos. 1 and 2; running thence N. 63-49 E. 74.7 feet to an iron pin; running thence S. 26-09 E. 155 feet to the point of beginning.
