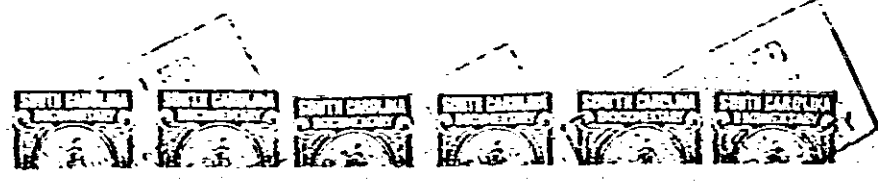

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as a portion of Lot No. 2 on a plat of the property of W.D. McBrayer dated January, 1935, prepared and executed by Dalton & Neves, recorded in Plat Book J at Page 37 in the RMC Office for Greenville County and having according to said plat the following metes and bounds to-wit:

BEGINNING at an iron pin on the Eastern side of Washington Avenue at the joint front corner of Lot No. 2 and Lot No. 17 and running thence with Lot 17 N38-04 E 255.4 feet; thence with Lot No. 1 North 47-20 West 54 feet to an iron pin; thence in a South Westerly direction 223 feet to an iron pin on the Eastern side of Washington Avenue; thence with said Avenue South 26-26 E 86 feet to the point of beginning.
