All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 28 on plat of Del Norte Estates, Sheet Two, recorded in Plat Book 1191 at page 33 in the RMC Office for Greenville County, and having the following metes and bounds:
