WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of NINE THOUSAND THREE HUNDRED FIFTY AND NO/100-----DOLLARS

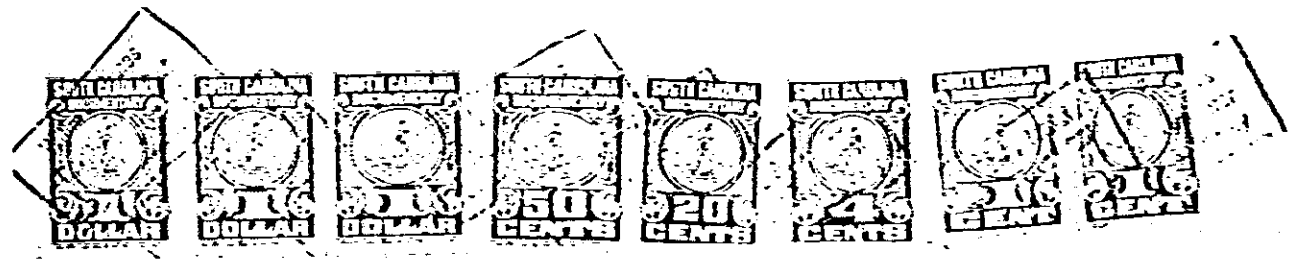

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Bennett Street in the City of Greenville, being shown and designated as Lot No. 12 and 30 feet of Lot No. 13 on plat of Northwood recorded in R.M.C. Office for Greenville County in Plat Book "J" at Pages 102 and 103, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on eastern side of Bennett Street, which pin is 100 feet south from corners of intersection of Bennett Street and Bowwood Road in front line of Lot No. 13; and running thence through Lot No. 13 S 71-32 E 150 feet to iron pin in line of Lot No. 11; thence with line of Lot No. 11 S 19-30 W 93 feet to iron pin on branch; thence with middle of said branch N 71-32 W 150 feet to iron pin on Bennett Street; thence with east side of Bennett Street N 19-30 E 93 feet to point of beginning.
