WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of EIGHTEEN THOUSAND DOLLARS

(\$ 18,000.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 18 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeast side of East North Street, in the city of Greenville, being shown as Lot # 16, on plat of the property of Overbrook Land Company, made by H. Olin Jones, September 17, 1913, recorded in plat book E at page 251, and described as follows:

Beginning at a stake on the southeast side of East North Street 26.3 feet southwest of Chestnut Street, at corner of Lot # 17, and running thence with the line of said lots S. 41-29 E. 184.8 feet to a stake; thence S. 39-42 W. 91 feet to a stake at corner of Lot # 15; thence with the line of said lot, N. 44-21 W. 192.8 feet to a stake on East North Street; thence with the southeast side of said street N. 41-28 E. 50 feet to a stake; thence N. 48-03 E. 50 feet to the beginning corner.
