(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

THIRTY THREE HUNDRED & NO/100 (\$3, 300) + + + + + DOLLARS

(\$ 3, 300. 00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is _____ years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Fairview Township, and being shown as all of Lot No. W-33 on plat of Section 4-W of Whipoorwill, prepared by Exwright Associates, Engineers, July 18, 1972, which plat is recorded in the RMC Office for Greenville County, South Carolina in Plat Book 4-R, at Page 26, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin at the edge of the turn-around marking the terminus of East Meadowlark Lane, at joint front corner of Lots W-33 and W-32; running thence with line of Lot W-32, S. 58-16 W. 140 feet to an iron pin; thence S. 31-44 E. 398.6 feet to iron pin; thence N. 58-16 E. 100 feet to iron pin; thence N. 4-20 W. 195.5 feet to iron pin; thence N. 31-44 W. 175 feet to iron pin, edge of said turn-around circle; thence along a curving course (the chord of which is N. 76-44 W.) 50 feet to point of beginning.
