All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Shallowford Road, near the City of Greenville, being shown and designated as Lot 500 on Section D of Plat of Gower Estates recorded in Plat Book RR, Pages 192-193, and having according to said plat the following metes and bounds, to-wit:
