TO ALL WHOM THESE PRESENTS MAY CONCERN: Charles J. Baisley and Juanita C. Baisley

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty-five Thousand Nine Hundred and No/100

DOLLARS

(\$ 35,900.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of New Haven Drive, near the City of Greenville, S. C., being designated as Lot No. 87 on the plat of Merrifield Park, Section No. II, as recorded in the RMC Office for Greenville County, S. C., in Plat Book WW, page 51 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of New Haven Drive, joint front corner of Lots 87 and 88 and running thence along the common line of said lots S 53-54 E 158.8 feet to an iron pin; thence S 45-38 W 110.7 feet to an iron pin, joint rear corner of Lots 86 and 87; thence along the common line of said lots N 50-33 W 168.15 feet to an iron pin on the southeasterly side of New Haven Drive; thence along said Drive N 40-35 E 115 feet to an iron pin, the point of beginning.
