"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the North side of Club Drive being shown as all of Lot 48 on plat of Property of Ables and Razor, which plat is recorded in the RMC Office for Greenville County, S. C. in Plat Book E at Page 153, and having, according to a recent survey and plat by R. B. Bruce, RLS, dated August 31, 1967, the following metes and bounds:

BEGINNING at an iron pin on the North side of Club Drive at a point 162 feet Southwest of the intersection of said Street with Byrd Boulevard; thence N. 23-23 W. 177.5 feet to an iron pin; thence with the joint line of Lots 48 and 21, S. 65-36 W. 76.5 feet to an iron pin; thence S. 23-23 E. 177.7 feet to an iron pin on the North side of Club Drive; thence with the line of said Street, N. 65-30 E. 79 feet to the point of beginning.
