Rosamond Enterprises, Inc. (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty-Nine Thousand Two Hundred and No/100 ----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Mauldin, being known and designated as Lot No. 9 on plat of FORRESTER WOODS, SECTION 7, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-P, at pages 21 and 22, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Oakwood Court joint front corner Lots 9 & 10; running thence with the line of said lots S. 58-57 E. 155 feet to an iron pin; running thence N. 36-18 E. 92.3 feet to an iron pin joint rear corner Lots 8 & 9; running thence with the joint line of said lots N. 53-42 W. 155 feet to an iron pin on the southern side of Oakwood Court; running thence down the southern side of Oakwood Court S. 36-18 W. 92.8 feet to a point; thence continuing with Oakwood Court S. 31-03 W. 19.3 feet to the point of beginning.
