Jim Vaughn Enterprises, Inc.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty Six Thousand Three Hundred Fifty and 00/100-----DOLLARS

(\$ 26,350.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five (25) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southerly side of Bronsfield Road, being shown and designated as Lot No. 464, on plot of Del Norte Estates, Section V, recorded in the RMC Office for Greenville County, S. C., in Plat Book "4 R", at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of Bronsfield Road, joint front corner of Lots Nos. 464 and 465, and running thence with the line of said Lots, S. 5-58 E. 130.0 feet to an iron pin, the joint rear corner of said Lots; thence with the line of Lot No. 442, S. 84-02 W. 95.0 feet to an iron pin, the joint rear corner of Lots Nos. 463 and 464; thence with the line of said Lots, S. 5-58 W. 130.0 feet to an iron pin on the Southerly side of Bronsfield Road; thence along the Southerly side of Bronsfield Road, N. 84-02 E. 95.0 feet to an iron pin, the point of BEGINNING.
