WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of **thirty-three thousand and six hundred and no/100**----- DOLLARS

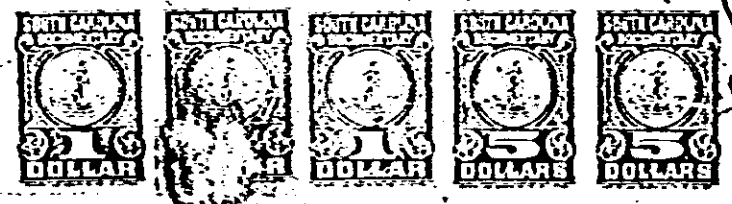
(\$ 33,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **29** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located at the intersection of Dawnwood Drive and Coach Hills Drive, and being known and designated as Lot No. 184 on plat of Coach Hills recorded in the R. M. C. Office for Greenville County in Plat Book 4-X at page 86, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on Dawnwood Drive at the joint front corner of Lots Nos. 184 and 185, and running thence with the joint line of said lots, N. 10-52 W. 153.08 feet to iron pin; thence N. 79-10 E. 100 feet to an iron pin on Coach Hills Drive; thence with Coach Hills Drive, S. 10-57 E. 127 feet to an iron pin at the intersection of Coach Hills Drive and Dawnwood Drive; thence with the curvature of said intersection, the chord of which is S. 33-46 W. 35.52 feet to iron pin on Dawnwood Drive; thence with Dawnwood Drive, S. 78-30 W. 75.17 feet to the beginning corner.
