(hereinafter referred to as Mortgagor) SEND (S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Thousand and no/100----- DOLLARS (\$ 14,000.00----- ), with interest thereon from date at the rate of Five & three-fourths per centum per annum, said principal and interest to be repaid in monthly instalments of One Hundred Four and no/100--- Dollars (\$104.00 ) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northern side of East North Street and having, according to Plat of property of Mr. and Mrs. Wilton H. Earle recorded in Plat Book F at page 137, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of East North Street, in the City of Greenville, which pin is 54.5 feet East from the corner of the intersection of East North Street and Glover Street, and running thence S. 21-28 E. 38.8 feet to a pin; thence S.20-23 E. 97 feet to pin; thence S. 21-24 E. 44.2 feet to iron pin; thence N. 76-45 E. 63.5 feet to an iron pin; thence S. 21-45 E.180 feet to iron pin on East North Street; thence with the Northern side of East North Street, S. 76-45 W. 65.5 feet to an iron pin, point of beginning.
