WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Five Thousand and no/100----- DOLLARS (\$25,000.00-----), with interest thereon at the rate of eight (8%)----- per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, lying on the northeastern side of Riviera Drive, being shown and designated as Lot No. 257, Sector V, on a plat of Botany Woods, recorded in the R.M.C. Office for Greenville County in Plat Book YY, pages 6 and 7, and, according to said plat, has the following courses and distances, to wit:

BEGINNING at an iron pin on the northeastern side of Riviera Drive, the joint front corner of Lots 257 and 256 and running thence with the line of Lot 256, N. 17-59 E. 193.5 feet to a pin in the line of Lot No. 249; thence with the rear line of Lots 249 and 248, S. 80-08 E. 95 feet to the rear corner of Lot 258; thence with the line of Lot 258, S. 16-21 W. 200.7 feet to a pin on Riviera Drive; thence with the northeastern side of Riviera Drive, N. 75-47 W. 100 feet to an iron pin, the point of beginning.
