(\$ 51,350.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 29 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

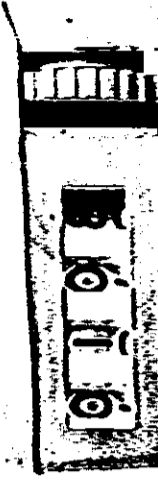
All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Mustang Circle in Austin Township, being shown and designated as Lot No. 28, on a plat of the subdivision of S. I. Ranchettes, Section 1, made by Dalton & Neves, Engineers, dated April 1965 and recorded in the RMC Office for Greenville County, S. C. in plat book JJJ at page 31, and having according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Mustang Circle at the joint front corners of Lots Nos. 27 & 28, and running thence along the common line of said lots N. 38-14 W. 601.1 feet to an iron pin; thence S. 58-27 W. 160 feet to an iron pin; thence S. 10-49 W. 149 feet to an iron pin; thence S. 46-41 E. 719.2 feet to an iron pin on Mustang Circle; thence with the curve of the northwestern side of Mustang Circle, N. 16-10 W. 168.3 feet to an iron pin; thence continuing with the curve of side of Mustang Circle, N. 33-43 E. 107.5 feet to an iron pin at the beginning corner.
