(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

SEVEN THOUSAND AND NO/100 DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of Five & Three-fourths (5-3/4) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Pates Township, Greenville County, South Carolina, being shown and designated as Lot No. 1 of subdivision known as Mountain View Acres, and according to plat of same made by Jones & Southerland, Engineers, April 18, 1958, having the following rates and bounds, to-wit:

BEGINNING at a point in the center of a surface treated County Road, at the intersection of Farningdale Drive, and running thence with Farningdale Drive, S. 86-58 E. 225 feet to corner of Lot No. 2; thence S. 3-07 W. 203.2 feet; thence N. 71-14 W. 233.8 feet to the center of said County road; thence with the center of said County Road, N. 3-07 E. 139 feet to the point of beginning.
