(hereinafter referred to as Mortgagor) SEND(S) GREETING(S)

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Forty-Two Thousand Four Hundred Fifty and No/100 DOLLARS (\$ 42,450.00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, being shown as Lot No. 28 on plat of Old Mill Estates, Section I, as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 000, at Page 159, and having, according to said plat, the following courses and distances, to-wit:

BEGINNING at a point on the edge of Old Mill Court, joint front corner of Lots Nos. 26 and 28, and running thence with said Road, S. 56-00 E. 75 feet to a point; thence, S. 8-58 E. 49 feet to a point, joint front corner of Lots Nos. 28 and 30; thence with the common line of said lots, S. 36-12 W. 259.5 feet to a point in or near a mountain creek; thence with said creek as the line, N. 55-04 W. 50 feet and N. 48-35 W. 10.5 feet to a point, joint rear corner of Lots Nos. 28 and 26; thence with the common line of said lots, N. 26-37 E.
