WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Thirty-Five Hundred and No/100

DOLLARS (\$ 3500.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be repaid in monthly instalments of Thirty and No/100 Dollars (\$ 30.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the northern side of County Road, being shown and designated as Tract No. 7 on plat of property of D. J. Hudson, made by W. J. Riddle, recorded in Plat Book I at Page 143, and described as follows:

"BEGINNING at an iron pin on the northern side of said County Road, at the joint front corner of Tracts Nos. 6 and 7, and running thence with line of Tract No. 6, N. 9-30 E. 639 feet to iron pin on branch; thence with the branch as the line, N. 87-27 W. 294.7 feet to an iron pin at rear corner of Tract No. 8; thence with line of Tract No. 8, S. 7-30 W. 551 feet to pin on County Road; thence with said Road as the line, N. 69-23 E. 278 feet to the point of beginning."
