All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, situate, lying and being on the northern side of Hillendale Circle, being a portion of Lot 16 as shown on plat of J. M. Black property, recorded in Plat Book S, Page 59, and described as follows:

Beginning at a stake on the northern side of Hillendale Circle, 851 feet west from Crestwood Drive and running thence N 4-55 W 227 feet to a stake; thence N 86-42 W 208 feet to a stake in line of Lot 15; thence with the line of said lot, S 16-42 E 250 feet to a stake on Hillendale Circle; thence with the northern side of Hillendale Circle, N 89-10 E 157 feet to the point of beginning.
