(hereinafter referred to as Mortgagor) is well and truly indebted unto MOTOR CONTRACT COMPANY OF Greenville its successors and assigns forever (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seven Thousand Four Hundred Nineteen Dollars and NO/100 Dollars (\$ 7,419.00) due and payable in monthly installments of \$ 123.65, the first installment becoming due and payable on the 26 day of July, 1973 and a like installment becoming due and payable on the same day of each successive month thereafter until the entire indebtedness has been paid, with interest thereon from maturity at the rate of seven per centum per annum, to be paid on demand.

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, to wit: All that piece, parcel or lot of land situate, lying and being on the southern side of Foxhall Road near the City of Greenville, County of Greenville, State of South Carolina, and known and designated as Lot No. 251 of a subdivision known as Section B, Woodfields, plat of which is recorded in the R.M.C.
