WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Forty Five Thousand Three Hundred and 10/100 DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southern side of East Seven Oaks Drive in Gantt Township, being shown and designated as Lot 99 on a plat of Section 2 of Chanticleer, recorded in Plat Book JJJ at page 71 and having, according to said plat, the following metes and bounds:
