"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville, being shown and designated as Lots 88 and 89 of Tanglewood as shown on plat recorded in Plat Book GG at page 193 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Yown Road at the joint front corner of Lots 87 and 88 and running thence with the line of Lot 87, N. 13-55 W. 186.5 feet to pin; thence S. 57-88 W. 102 feet to pin in line of Lot 95; thence with line of Lot 95, S. 37-23 W. 142.3 feet to pin at the rear corner of Lot 91; thence with the line of Lot 91, S. 8-54 W. 134.2 feet to pin at the corner with the line of Lot 90, S. 81-45 E. 162.feet to pin on Yown Road; thence with the northwestern side of said Road, pin on Yown Road; thence with the northwestern side of said Road, N. 8-15 E. 10 feet to pin; thence continuing N. 24-45 E. 70 feet to pin; thence N. 57-36 E. 70 feet to pin at corner of Lot 87, the beginning corner.
