TO ALL WHOM THESE PRESENTS MAY CONCERN:

ALBERT TAYLOR

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Four Thousand Five Hundred and No/100ths DOLLARS
(\$ 4,500.00), with interest thereon at the rate of eight (8) per cent per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 8 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference, and

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the Northeast side of East Gantt Street, being known as and shown as Lot No. 19 on a plat of property entitled "Property of Albert Q. Taylor", near Greenville, South Carolina, dated May, 1946, by Dalton & Neves, and recorded in the R.M.C. Office for Greenville County in Plat Book P, at page 49, and having, according to the said plat, the following metes and bounds, to-wit:
