ALL that certain piece, parcel or lot of land lying and being in the State of South Carolina, County of Greenville, being known and designated as Tract No. 1 and Tract No. 2 as shown on plat of property of Harbor Town Limited Partnership, dated July 1, 1975, prepared by W. R. Williams, Jr., and being more fully described in said plat as follows:
