We, Wilbur Jean Hester Freeman and Bruce L. Freeman,

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Paris Mountain Township, being situate on the Eastern side of Crestview Drive, and being shown as Lot 37.1, Block 1, Page 433, on the County Block Book, and being more particularly described as follows:

BEGINNING at an iron pin at the Southwest corner of a 4.3 acre tract owned by W. M. Hester, and running thence S. 80 E. 200 feet to an iron pin; thence N. 1 W. 100 feet to an iron pin; thence N. 80 W. 200 feet to an iron pin on Crestview Drive; thence with the Eastern side of Crestview Drive, S. 1 E. 100 feet to the point of beginning.
