All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot 33 of the Property of Wade Cothran as shown by plat thereof recorded in the REC Office for Greenville County in Plat Book H, at page 163, and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the northern side of Warner Street, said iron pin being located approximately 194.2 feet from the intersection of Warner Street and Pherson Avenue, said iron pin being the joint front corner of Lot 33 and Lot 32 and running thence N. 9-35 E. 165 feet to an iron pin; thence N. 81-15 W. 65 feet to an iron pin; thence S. 9-35 W. 165 feet to an iron pin, being the joint front corner of Lots 33 and 34; thence with the northern side of Warner Street, S. 81-15 E. 65 feet to the point of BEGINNING.
