TO ALL WHOM THESE PRESENTS MAY CONCERN: Florence Comer

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Six Thousand Three Hundred and no/100----

DOLLARS (\$6, 300. 00), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, near Greenville, S. C. known as lot no. 10 on plat of property of Forest View made by T. C. Adams dated February, 1955 and recorded in the R. M. C. Office for Greenville County in Plat Book II at Page 105 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Gilstrap Drive, at the joint front corner of lots nos. 9 and 10, which iron pin is situate 88.6 feet west of the intersection of Gilstrap Drive and Galphin Drive and running thence along the line of lot no. 9, N. 10-16 W. 192.7 feet to an iron pin, corner of lot no. 9; thence with the line of lot no. 3, N. 84-29 E. 100.3 feet to an iron pin on the western side of Gilstrap Drive, which iron pin is situate 185 feet south of Galphin Drive, and running thence along the western side of Gilstrap Drive, S. 10-16 E. 188.6 feet to an iron pin; thence following the curved intersection of Gilstrap Drive and Galphin Drive, the chord of which is
