Office for Greenville County in Plat Book YY, at Page 117, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Imperial Drive, at the joint front corner of Lots 23 and 24 and running thence along Imperial Drive, S. 58-08 E. 49 feet to an iron pin; thence, still with Imperial Drive, S. 52-13 E. 51.0 feet to an iron pin at the joint front corner of Lots 24 and 25; thence along the line of Lot 24, S. 32-26 W. 184.8 feet to an iron pin; thence N. 69-45 W. 100.0 feet to an iron pin at the joint rear corner of Lots Nos. 23 and 24; thence along the line of Lot No. 23, N. 31-52 E. 210.0 feet to the beginning corner.
