WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Five Thousand and No/100 DOLLARS

(\$ 25,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is twenty-five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeasterly side of Crestwood Drive, near the City of Greenville, S. C., and being designated as Lot No. 109 on plat entitled "Addition to Buxton" as recorded in the RMC Office for Greenville County, S. C., in Plat Book 4N, page 4 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeasterly side of Crestwood Drive, joint front corner of Lots 109 and 110 and running thence along the common line of said lots S 50-19 E 176.6 feet to an iron pin in right of way of Duke Power Company; thence W 40-42 E 102.3 feet to an iron pin; thence N 9-44 E 15.3 feet to an iron pin; thence N 9-53 W 10 feet to an iron pin in line of Lot 108; thence along the common line of Lots 108 and 109 N 51-53 W 164.18 feet to an iron pin on the southeasterly side of Crestwood Drive; thence along said Drive S 40-25 W 120 feet to an iron pin, the point of beginning.
