"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northerly side of Crowndale Drive, being shown and designated as Lot No. 104, on plat of Gray Fox Run, recorded in the RMC Office for Greenville County, S. C., in Plat Book "5 P", at Page 9, and having, according to said plat, the following metes and bounds, to wit:
