TO ALL WHOM THESE PRESENTS MAY CONCERN:

CHARLES H. AND FAITH B. ROSS (hereinafter referred to as Mortgagor) SEND(S) GREETING

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

TWENTY SEVEN THOUSAND FIVE HUNDRED AND NO/100THS----- DOLLARS

(\$ 27,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is Twenty-Five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern end of Halloway Circle, being shown and designated as Lots Nos. 30 and 31 on a plat entitled "Revision of Grandview Hills" made by R. B. Bruce, Surveyor, dated March 26, 1969, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book WW, at page 52, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern end of Halloway Circle on a cul-de-sac at the joint corner of Lots Nos. 31 and 42 (Lot No. 42 has heretofore been sold according to description in Plat Book XX, page 173); thence with the common line of said Lot, S 1-10 W 170 feet to an iron pin; thence S 76-33 W 103 feet to an iron pin at the joint rear corner of Lots Nos. 31 and 25; thence with the joint line of said lots, N 32-24 W 151.9 feet to an iron pin at the joint rear corner of Lots Nos. 25 and 30, N 32-24 W 110 feet to an iron pin at the joint rear corner of Lots Nos. 25, 29 and 30; thence N 49-51 E 160 feet to an iron pin on the western side of Halloway Circle; thence along said Circle, S 45-18 E 105.5 feet to an iron pin; thence continuing along said Circle, S 5-09 E 18 feet to an iron pin at the joint front corner of Lots Nos. 30 and 31; thence along the cul-de-sac of said Circle, the chord of which is S 51-03 E 60 feet to an iron pin, the beginning corner.
