*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southeastern side of Prentiss Avenue in the City of Greenville, being shown and designated as Lot 10, Block K, on plat of the property of O. P. Mills, recorded in Plat Book F at page 224, and having the following metes and bounds according to said plat:

BEGINNING at an iron pin on the southeastern side of Prentiss Avenue on the joint front corner of Lots 10 and 11, and running thence along the southeastern side of Prentiss Avenue, N. 45-27 E. 62 feet to pin at corner of Lot 9; thence with line of Lot 9, S. 44-33 E. 180 feet to pin; thence S. 45-27 W. 62 feet to pin at rear corner of Lot 11; thence with line of said lot, N. 44-33 W. 180 feet to the beginning corner.
