(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Thousand and No/100-----  
DOLLARS (\$14,000.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as Lot 27, according to a map or plat of Oakland Terrace as made by C. C. Jones, and associates, Engineers, in June, 1957, which plat is of record in the R. M. C. Office in Plat Book BB at Page 196, and described as follows:

BEGINNING at an iron pin on the northwestern side of Zelma Drive, at the corner common to Lots 26 and 27, and running thence along the dividing line between Lots 26 and 27, N. 48-35 W. 170 feet to an iron pin; thence S. 41-25 W. 100 feet to an iron pin at the corner of Lot 28; thence with the dividing line between lots 27 and 28 S. 48-35 E. 170 feet to an iron pin on the northwestern side of Zelma Drive; thence along Zelma Drive N. 41-25 E. 100 feet to the place of beginning.
