WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Three Hundred Forty-six Thousand Five Hundred and No/100-----DOLLARS

(\$ 346,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Northwestern side of Haywood Road being known and designated as a 6.02 acre tract as shown on a plat prepared by Carolina Engineering & Surveying Co., entitled "Survey for Yeargin Property", dated September 19, 1968, and recorded in the R.H.C. Office for Greenville County, South Carolina, in Plat Book ZZZ at page 101 and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northwestern side of Haywood Road at the Southern corner of the premises herein described and at the Eastern edge of the right of way for the Atlantic Coast Line Railroad Company, and running thence with the Eastern edge of said right of way N. 29-41 W. 742 feet to an iron pin; thence with the line of property now or formerly of Walter Goldsmith and A. Foster McKissick, as Trustees, N. 60-19 E. 400 feet to an iron pin; thence continuing with the line of the said Walter Goldsmith and A. Foster McKissick, as Trustees, property S. 29-41 E. 620.5 feet to an iron pin on the Northwestern side of Haywood Road; thence with the Northwestern side of Haywood Road S. 43-21 W. 417.9 feet to the point of beginning.
