All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Gantt Township, being more fully described as follows:

BEGINNING at an iron pin on the road near the lake at joint front corner of tracts 1 and 2 according to plat of Oakvale Land Company made by G. A. Ellis, June 15, 1936, and running thence along said road N. 31 E. 210 feet to pin at joint front corner of tracts 2 and 3; thence with line of tract 3 N. 85-20 W. 1530 feet to iron pin on creek; thence along creek as line 300 feet, more or less, to iron pin at corner of Lot No. 1; thence with line of Lot No. 1 S. 85-20 E. 1637 feet to the point of beginning, containing 6.9 acres and being shown as tract 2 on the above referred to plat.
