(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of EIGHTEEN THOUSAND and no/100----- DOLLARS

(\$ 18,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the Northern side of McDaniel Court (formerly Carroll Street) being shown and designated as Lot No. 4 on a Plat of the Property of Shirley L. Styles, made by Dalton & Neves, dated October, 1950, recorded in the RMC Office for Greenville County, South Carolina in Plat Book L, Page 151 and having according to a more recent plat made by Piedmont Engineers and Architects, dated August 25, 1950, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of McDaniel Court, which iron pin is 144.7 feet from the intersection of McDaniel Court and McPherson Lane, which point is the joint front corner of Lots No. 3 and 4, and running thence with the joint line of said lots, N. 15-38 E., 182 feet to a point; thence N. 15-34 W., 29 feet to an iron pin on the bank of a branch, with the branch being the line, the traverse of which is S. 63-01 W., 68.7 feet to an iron pin; thence S. 18-19 W., 159.2 feet to an iron pin on the Northern side of McDaniel Court; thence running with the Northern side of the said McDaniel Court, S. 73-22 E., 72 feet to the point and place of beginning.
