Hella Annette Batson (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five thousand - - - - - and no/100ths - - - - - DOLLARS

(\$ 5,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 8 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southeastern side of Franklin Road, being shown and designated as Lot No. 2 on a plat of Sans Souci Villa, recorded in Plat Book C at Page 131 in the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the eastern side of Franklin Road, 56 feet in a northeasterly direction from the intersection of Franklin Road and Young Street, and running thence with line of Lot 3, S 57-25 E 165 feet 4 inches to stake in line of Lot 4; thence with line of Lot 4, N 27-30 E 56 feet 2 inches to pin at the rear corner of Lot 1; thence with line of Lot 1, N 57-25 W 160 feet 8 inches to pin on Franklin Road; thence with the eastern side of Franklin Road S 32-35 W 56 feet to the point of beginning.

This being the same property conveyed to the mortgagor by deed of Horace A. Morris and Catherine W. Morris recorded in Deed Book 717 at page 365.
