TO ALL WHOM THESE PRESENTS MAY CONCERN:

J. C. McDowell, Jr. and Mildred McDowell
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Nine Thousand Five Hundred and no/100-----**
DOLLARS (\$ 9,500.00---), with interest thereon from date at the rate of **Six (6%)---** per centum per annum, said principal and interest to be repaid in monthly instalments of **Sixty Eight and no/100---** Dollars (\$68.00) each on the first day of each month hereafter until the principal and interest are fully paid; each payment to be applied first to payment of interest and then to payment of principal, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the North side of Folkstone Street, being shown and designated as Lot 111 on a plat of Chestnut Hills No. 1, recorded in Plat Book QQ at page 83, and having according to said plat the following:

BEGINNING at an iron pin on the Northern side of Folkstone Street at the joint front corner of Lots 110 and 111 and running thence with the line of Lot 110, N. 7-55 E. 140 feet to a pin; thence S. 82-05 E. 80 feet to the rear corner of Lot 112; thence with the line of Lot 112, S. 7-55 W. 140 feet to a pin on Folkstone Street; thence with the Northern side of Folkstone Street, N. 82-05 W. 80 feet to the point of Beginning.
