WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, All that lot of land with the buildings and improvements thereon situate on the east side of Agewood Drive in the Town of Simpsonville, Austin Township, Greenville County, South Carolina, being shown as Lot 517, Section V, Sheet One on plat of Westwood Subdivision, made by Piedmont Engineers and Architects, November 28, 1972, recorded in the RMC Office for Greenville, S. C. in Plat Book 4-X Page 63 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Agewood Drive at the joint corner of Lots 516 and 517 and runs thence along the line of Lot 516 S. 88-17 E 140 feet to an iron pin; thence along the line of Lot 515 and 519 N 2-52 E 86 feet to an iron pin; thence along the line of Lot 518 N 88-17 W 140 feet to an iron pin on the east side of Agewood Drive; thence along Agewood Drive S 2-50 W 86 feet to the beginning corner.
