WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate at the Southeast corner of the intersection of Old Spartanburg Road and Beaufort Street in Butler Township, Greenville County, being shown as Lot 15 on a plat of Spring Forest I, recorded in Plat Book XX at page 126, and having according to said plat having the following metes and bounds:

BEGINNING at an iron pin on the Southern side of Old Spartanburg Road, at the joint corner of Lots 14 and 15 and running thence with the line of Lot 14, S. 7-27 E. 180 feet to a pin; thence with the line of Lot 27, S. 82-37 W. 112 feet to a pin on Beaufort Street; thence with the Eastern side of Beaufort Street, N. 7-23 W. 155 feet to a pin; thence with the curve of the intersection of Beaufort Street and Old Spartanburg Road, the chord of which is N. 37-10 E. 35.6 feet to a pin on Old Spartanburg Road; thence with the Southern side of Old Spartanburg Road, N. 82-37 E. 87 feet to the point of Beginning.
