Whereas, We, the said Alvin J. Duncan and Unice Mae Duncan,

the full and just sum of Two thousand seven hundred and fifty (\$2,750.00)

to be paid in monthly installments of fifteen dollars (\$15.00)
beginning on the 16th day of December, 1954, and fifteen dollars (\$15.00) on

with interest thereon from date of maturity at maturity
