WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Sixteen Thousand and No/100-----  
DOLLARS (\$ 16,000.00 ), with interest thereon from date at the rate of Five & one-fourth per centum per annum, said principal and interest to be repaid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the Southwest side of Shannon Drive, being shown as Lot No. 2 on Plat of Section 4 of Lake Forest, made by C. O. Riddle, February, 1956, recorded in the REC Office for Greenville County, S. C., in Plat Book "JJ", page 115, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Southwest side of Shannon Drive, joint corner of Lots 1 and 2, and running thence with the line of Lot 1, S. 59-25 W., 154.9 feet to an iron pin; thence S. 30-35 E., 169.8 feet to an iron pin; thence S. 27-51 W., 23.9 feet to a point on the high water mark of Lake Fairfield; thence along the line of the high water mark of Lake Fairfield, S. 42-29 E., 38 feet to a point; thence N. 32-53 E., 87.4 feet to a point; thence N. 53-51 E., 100 feet to an iron pin on the Southwest side of Shannon Drive; thence along Shannon Drive, N. 36-09 W., 106 feet to a point; thence continuing along Shannon Drive, N. 30-35 W., 65 feet to an iron pin, the point of beginning.
