WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 103 on plat of the property of East Lake Subdivision recorded in Plat Book JJ, Page 123, and being more particularly described as follows:

BEGINNING at an iron pin on the southeastern side of East Circle Avenue at the corner of Lot 102 and running thence with the line of Lot 102 S. 17-42 E. 150 feet to stake; thence N. 60-02 E. 98.9 feet to stake corner of Lot 104; thence with the line of Lot 104 N. 32-42 W. 150 feet to stake on East Circle Avenue; thence with the southeastern side of said avenue S. 57-18 W. 60 feet to the beginning corner.
