TO ALL WHOM THESE PRESENTS MAY CONCERN,  
RICHARD H. PARKER AND MARY M. PARKER

(hereinafter referred to as Mortgagor) SENDS GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of THIRTEEN THOUSAND EIGHT HUNDRED SEVENTY-FIVE AND NO/100THS DOLLARS (\$13,875.00-----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City and County of Greenville, State of South Carolina, designated as Lot No. 44 on a Plat of Meyers Park Subdivision, Section II, prepared by C. O. Riddle, RLS, on September 27, 1976, and recorded in the RMC Office for Greenville County in Plat Book 5-P at Page 54, and having the following courses and distances:

BEGINNING at an iron pin at the joint front corner of Lot No. 45 on the South-eastern side of Forest Lane, and running thence along Lot No. 45, S. 43-41 E. 229.9 feet to the center of a branch; thence along said branch as the line, the traverse line of S. 5-36 W. 138.14 feet to a point in said branch; thence along the line of Greenville Country Club N. 54-14 W. 15 feet to a point; thence along the rear of Lot 44 S. 78-04 W. 108.47 feet to an iron pin; thence along Lot No. 43 N. 25-10 W. 280.76 feet to an iron pin on Forest Lane; thence along Forest Lane N. 55-34 E. 112 feet to the beginning.
