WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Six Thousand and No/100-----DOLLARS

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Gary Avenue and being known and designated as Lot No. 16 on a plat entitled "Map No. One, Cunningham Acres" and recorded in the RMC for Greenville County in Plat Book BBB at Page 118, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the south side of Gary Avenue at the joint front corner of Lots 15 and 16 and running thence with the common line of said Lots S.5-20 W. 165 feet to an iron pin at the joint rear corner of said Lots; thence N.84-40 W. 120 feet to an iron pin at the joint front corner of Lots 16 and 17; thence with the common line of said Lots N.5-20 E. 165 feet to an iron pin on Gary Avenue; thence with said Avenue S.84-40 E. 120 feet to the point of beginning.
