WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of thirty-nine thousand nine hundred and no/100----- DOLLARS

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 189 of a subdivision known as Coach Hills as shown on a plat prepared by Piedmont Engineers-Architects-Planners, dated September 26, 1974 and recorded in the RMC Office for Greenville County in Plat Book 4X, pages 85 and 86. Sheet 2 of said plat was revised on November 25, 1974 and recorded in the RMC Office for Greenville County in Plat Book 4X at page 94 and having, according to said plat, as revised, the following metes and bounds, to-wit:

Beginning at an iron pin on the northern side of Dawnwood Drive at the joint front corners of Lots 189 and 190 and running thence with the lines of Lots 190 and 191 N. 0-57 W. 160.69 feet to an iron pin in the rear line of Lot 178; thence with the rear lines of Lots 178 and 179 N. 86-54 E. 93.30 feet to an iron pin at the joint rear corners of Lots 188 and 189; and running thence with the joint line of said lots S. 3-05 E. 151.33 feet to an iron pin on the northern side of Dawnwood Drive, joint front corner of Lots 188 and 189; thence with the northern side of Dawnwood Drive S. 86-56 W. 4.92 feet and S. 81-11 W. 94.90 feet to the point of beginning. Being the same property conveyed to the mortgagors by deed of Southland Properties, Inc. dated July 27, 1976 and recorded in Deed Book 1040 at Page 241.
