All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the Southwest side of Kathryan Drive, near the City of Greenville, being shown as Lot 29 on a plat of Chestnut Hills Number One, recorded in Plat Book QQ at page 83, and described as follows:

BEGINNING at an iron pin on the Southwestern side of Kathryan Drive, at the corner of Lot 28 and running thence with the line of said lot, S. 11-43 W. 150.2 feet to an iron pin; thence N. 85-24 W. 142 feet to an iron pin; thence N. 2-05 W. 120 feet to an iron pin at the corner of Lot 30; thence with the line of said lot, N. 69-12 E. 153.9 feet to an iron pin on Kathryan Drive; thence with the Southwestern side of said Drive, S. 45-20 E. 62 feet to the Beginning Corner.
