MICHAEL D. WESTBROOK AND JANE B. WESTBROOK

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of THIRTY-ONE THOUSAND NINE HUNDRED AND NO/100 (\$31,900.00)-----DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being on the northern side of Confederate Circle, Taylors, South Carolina, and being further known and designated as Lot 98, on a plat of Sheffield Forest, Section III, made by Carolina Engineering and Surveying Company, dated May 26, 1965, recorded in the RMC Office for Greenville County in Plat Book 3I, at page 157, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Confederate Circle at the joint front corner of Lots 97 and 98 and running along Confederate Circle S. 84-00 W. for 100 feet to an iron pin at the joint front corner of Lots 98 and 99; thence turning and running along the joint line of Lot 99, N. 06-00 W. for 311.3 feet to an iron pin; thence turning and running S. 64-08 E. for 136.6 feet, thence S. 55-02 E. for 54 feet, thence S. 06-00 E. for 218.1 feet to the point of beginning.
